

## Stalwart Agricultural Fair Personal Motorized Vehicle Use and Safety Agreement

The purpose of this agreement is to outline the Stalwart Fair's expectations and rules concerning the use of personal golf carts, ATVs, side by sides, and other motorized vehicles (*from hereon called, "personal vehicles"*) that are brought to the fairgrounds for personal use.

This agreement will outline:

1. Permissible Use
2. Safe Operation
3. Driver Responsibility
4. Insurance and Liability Requirements

### PERMISSIBLE USE

1. The Stalwart Fair will allow the use of personal vehicles on the fairgrounds during fair events.
2. The owners and operators of these vehicles must register the use of their personal vehicles at the front office to receive a parking permit or placard.
3. The parking permit or placard must be prominently displayed while the vehicle is in use.
4. New placards will be issued each year.

### SAFE OPERATION

1. All drivers shall observe all vehicle traffic laws while driving golf carts (e.g. stopping at stop signs, yielding to pedestrians, no cell phone usage or texting while driving).
2. **In a golf cart, ORV, side by side, or other personal vehicle, the number of passengers and load capacity shall not exceed the manufacturer's rated limit.**
3. All Passengers must be seated while operating the vehicle.
4. Pedestrians and horses always have the right of way over any vehicles on the fairgrounds.
5. Drivers must not exceed 10 M.P.H. while operating motorized carts and vehicles.
6. Vehicles must NOT block any entrance to buildings, stairways, ramps, or thoroughfares.
7. Vehicles must have working headlights when and if operating at night.

### DRIVER RESPONSIBILITY

1. Drivers must have a valid driver license – NO EXCEPTIONS
2. Authorized vehicle owners must review this policy and sign the agreement.
3. In the event of an accident involving a personal vehicle, report the incident immediately to the front office during office hours or contact a Fair Board Member to file an accident report.
4. Reckless or gross negligent driving or allowing someone else to operate your personal vehicle who is operating negligently, may automatically revoke your privilege to bring and/or operate golf carts, ATVs, side by sides, or other personal motorized vehicles on the fairgrounds immediately and in the future.
5. All operators and owners will observe campground quiet times and respect other campers and guests.

#### INSURANCE AND LIABILITY

1. Operators who provide a current and valid Handicapped permit will not be required to provide proof of additional insurance for their personal vehicle.
2. Operators who provide a handicapped permit will receive a designated placard.
3. All others requesting to use a personal vehicle on the fairgrounds will be required to provide a copy of their insurance declaration page that shows the liability coverage for the vehicle being used on the property.
4. Your insurance declaration page will be copied, affixed to your signed agreement, and retained in the fair's files for up to six months after the fair.

#### EXCEPTIONS

1. Guests and attendees who drive their side by side or similar vehicle to the fairgrounds as their primary transportation, will not be required to register or provide proof of liability insurance.
2. Additional exceptions may be made under board review.

Failure to comply with the established agreement may result in disciplinary action as appropriate. Depending on severity, frequency, and/or gross negligence; disciplinary actions may consist of current and future loss of personal vehicle privileges at the fairgrounds.
